For the SRT Phase II update, this week the City finally received the permit from DEC to proceed with SRT Phase II. Stantec is finalizing the project plans based on comments from DEC and NYSEG. When complete, these plans will then be sent to DOT for review and final approval. Once DOT approves, we will be able to bid out the Phase II work which is likely commence in the spring of 2020. Plans for SRT Phase III are on hold until details regarding the scope of the improvements to the City's Water Resource Recovery Facility and the City's larger plan for development of the harborside area are clarified. I'm not familiar with the LCBP Ruger Woods Grant or plans to connect the SRT and Blue Trails.

THIS AGREEMENT, entered into on	, by and between the County
of Clinton, a municipal corporation of New York (hereinafter refer	red to as "COUNTY"), having

River Trail Greenway, Inc. (hereinafter referred to as "GRANTEE")	, having its principal office
located at 135 Margaret Street –Suite 124, Plattsburgh, NY 12901	

WITNESSETH THAT:

WHEREAS, COUNTY has received funding from Tobacco Settlement proceedings, and has agreed to expend a portion of the funds received for community improvement projects within Clinton County that provide a public benefit; and

WHEREAS, by Resolution No. 294 of the Clinton County Legislature, duly adopted on April 26, 2017, Clinton County set forth a policy to award funding from the Tobacco Settlement Fund to worthy projects that provide a public benefit; and

WHEREAS, by Resolution No. 381 of the Clinton County Legislature, duly adopted on May 22, 2019, Clinton County awarded the amount of \$5,000 to the Saranac River Trail Greenway, Inc. for the purpose of trail improvement.

NOW, THEREFORE, it is mutually agreed by and between the parties hereto as follows:

- 1. COUNTY will pay to GRANTEE the sum of ten thousand dollars (\$5,000) for the purposes outlined in SECTION TWO below.
- 2. GRANTEE shall utilize the funding provided by COUNTY under this Agreement for the following specific purpose: trail improvement.
- 3. The terms of the payment of these funds by COUNTY to GRANTEE shall include the following:
 - A) GRANTEE shall only be paid for the purpose(s) described in SECTION TWO above.
 - B) GRANTEE shall furnish the COUNTY with an invoice(s) detailing the expenditures incurred to further the purpose specified in SECTION TWO above.

- C) COUNTY shall pay to GRANTEE all eligible expenses incurred, not to exceed the sum of \$5,000.
- D) GRANTEE must incur the expenses for the purpose specified in SECTION TWO on or before December 31, 2020, otherwise the COUNTY reserves the right to rescind this award in its entirely, or the portion of the award that remains unexpended by that date.
- 4. GRANTEE shall, at all times, indemnify and save harmless COUNTY from and against all claims and demands whatsoever, including costs, litigation expenses, counsel fees and liabilities in connection therewith arising out of injury to or death of any person whatsoever or damage to any property of any kind by whomever, owned, caused in whole or in part, directly or indirectly, by the acts or omissions of the GRANTEE, or any person employed by said GRANTEE, its contractors, subcontractors, or any person directly or indirectly employed by them, while engaged in the performance of the work to be performed by GRANTEE, or any activity associated therewith or relative thereto.
- 5. The GRANTEE shall not assign or transfer this Agreement or interest herein without first receiving written approval from COUNTY.
- 6. Changes in this Agreement shall be permitted only upon written approval by both COUNTY and GRANTEE.
- 7. GRANTEE shall comply with all applicable federal, state and municipal laws, ordinances and regulations.
- 8. GRANTEE shall cause to be executed the Memorandum attached as EXHIBIT 1, in compliance with New York County Law Section 224, and shall submit the signed document to the Clinton County Legislative office at 137 Margaret Street, Suite 208, Plattsburgh, NY 12901.

There is a webinar on June 11th but you don't need to wait for that. Check out their website and let me know if you need any other information.







I hope all is well in Dowtown at the Health Department. Ever busy, I am certain! I wanted to let you know that the section of trail (connecting Treadwell mills to the International Airport) that we presented to AFH a few months back is one step closer to reality. Our estimated cost to open the almost 2 mile section of trail was about \$10,000. On behalf of the SRTG, we applied for Tobacco Settlement funds and were awarded \$5000. NOTES AND NEXT STEPS: TRAIL EXTENSION TO RUGAR WOODS

NOTES

- Several members of the SRTG met on 5/22/2019 to walk the trail from its terminus at George Angell Drive through the property of Plattsburgh City School District, private property on Adirondack Lane, and on to SUNY property in Rugar Woods. Those present included: Jesse, Sean, Paula, Sara, Phil.
- Several routes for crossing Plattsburgh City School property were discussed. It
 was noted that going down by the football field (near the Webb Island) provided a
 better experience. There were several options from there for getting up to the
 field behind the new track. One pathway following close to the river another
 followed what appeared to be an access pathway used by vehicles.
- It was noted that the City School District recently had a capital plan improved that will include the upgrade to several athletic facilities. These may impact possible routes.
- The pathway from the School District across Adirondack Lane was discussed. Most of the property is owned by Terry Meron and the pathway down to the lake and near the city pumping station offers some opportunities for education about the history (industry / mills) via interpretative signs. It was agreed this pathway was picturesque. It also connects to SUNY property near the dam and the Frisbee golf course, adding an interesting amenity to the experience.
- The group walked back by Bowman Avenue and then retracted its pathway across the field. The group discussed the pros and cons of the pathway – do we go with the expeditious route across existing property (knowing this may not be the best experience) and then add a spur later, or strive for something now that may take longer but provides a better experience?

 It was agreed that we should reach out to the School District and see if we can schedule a meeting. But, it is critical that we know what we want when we do so.
 The group discussed pulling together some talking points.

Talking Points

- The Board is laying the groundwork to apply for the next phase of grants to extend the SRTG from its terminus at George Angell Drive. Our goal is to extend trail through PCSD property to connect to College property in Rugar Woods.
- There's many benefits to doing so. It links the existing trail to the large system of trails existing in Rugar Woods, it facilitates people getting around, it improves opportunities for emergency services to access locations, and it improves the quality of life to our community.
- PCSD has been a strong partner in the past, most recently when MJ Design came to do a preliminary review of possible trail alignment. MJ had identified a few possible routes from George Angell Drive to Rugar Woods.
- The SRTG PCSD recently had a capital plan approved by the voters. This may impact possible trail alignment, but it also improves opportunities to connect these facilities with the trail for use by our community. There may be possible win-win opportunities here.
- We have identified several possible pathways but we recognize that any potential pathway needs to serve the needs of all parties.
- With the recent approval of your capital plan, now seems like an idea time to discuss opportunities for collaboration.
